1. General Provisions

The following rules govern the organization and participation in the prize draw organized by GLS General Logistics Systems Slovenia, logistične storitve d.o.o.

The organizer of the prize draw is:

(hereinafter: the "Organizer")

The prize draw is conducted within the territory of the Republic of Slovenia and runs from **1 June 2026 to 2 August 2026**.

All participants entering the prize draw accept these Terms and Conditions, acknowledge that they have read them, fully agree to them by participating in the prize draw, and confirm that they meet all participation requirements. The Organizer considers that each participant, by submitting an entry or participating in any other way, has expressed their intention to participate and has accepted all provisions of these Terms and Conditions.

2. Purpose of the Prize Draw

The purpose of the prize draw is to promote the **GLS Send a Parcel service**, encourage the use of the **posljipaket.si** portal, and increase the use of **GLS Parcel Lockers**.

The advertising and implementation of the prize draw are carried out in accordance with applicable legislation. The prize draw may also be communicated and promoted on other social media platforms and websites.

3. Participants

The prize draw is open to all natural persons with permanent residence in the Republic of Slovenia.

The following persons may not participate:

- Employees of GLS General Logistics Systems Slovenia;
- Their immediate family members (spouse, partner, parents, children);
- Any other persons directly involved in the organization or implementation of the prize draw.

Each participant may participate only in their own name and, by participating, confirms that all personal data provided are their own and that they agree to these rules.

Participants must be at least **18 years of age**. If a participant or winner is under 18 years of age, they must be represented by a person over 18 years of age who is legally authorized and/or duly empowered to represent the minor.

4. Method of Participation

A participant may enter the prize draw by fulfilling all the following conditions:

4.1.

Between **1 June 2026 and 2 August 2026**, the participant sends a parcel via the **posljipaket.si** portal.

4.2.

In the final payment step, the participant enters the discount code:

"NAGRADA"

Each participant may enter the prize draw multiple times by sending multiple parcels.

Participants bear all costs associated with participation in the prize draw, including but not limited to internet access costs, electricity costs, postage costs, and similar expenses.

If the winner is a child and does not possess a valid identity document, the name and surname of the parent or legal guardian must be provided.

5. Participant Rules

5.1.

The winner expressly agrees that, in connection with the prize draw, the Organizer may publish their first and last name on the official **GLS Slovenia Instagram and Facebook pages**.

5.2.

Participants may not advertise any product or service, use inappropriate language, swear, or make statements that could be harmful or offensive to any person or authority. When participating, participants may not publish, transmit, or otherwise distribute content containing:

- Advertising or promotion of third-party products or services;
- Inappropriate, offensive, vulgar, or obscene language;
- Hate speech;
- Threats;
- Illegal, misleading, discriminatory, harmful, or offensive content;
- Content that infringes upon the rights, reputation, or dignity of others, the Organizer, or third parties.

The Organizer reserves the right to exclude such participants from the prize draw without prior notice.

6. Prizes

Prizes will be awarded every week, on Mondays.

During the prize draw period, the following prizes will be awarded through weekly drawings:

- Four (4) prizes valued at **EUR 1,000** each;
- Four (4) prizes valued at **EUR 350** each.

On the final day of the prize draw, one **grand cash prize of EUR 3,000** will be drawn among all participants who meet the participation requirements.

If incomplete, incorrect, or false information is provided, the Organizer reserves the right to reject the participant's entry or exclude them from the prize draw.

A participant forfeits the right to a prize if the Organizer determines that:

- The participant did not meet the participation requirements;
- The participant violated the prize draw rules;
- The participant refuses to fulfill obligations under these Terms and Conditions; or
- The participant fails to fulfill such obligations within the specified timeframe.

7. Prize Drawing and Winner Notification

Prize drawings will take place every Monday until the end of the prize draw.

One participant meeting the requirements of Article 4 will be randomly selected from all eligible participants.

The drawing process will be electronically recorded and documented in official minutes. The records shall be kept at the Organizer's registered office in accordance with these rules.

The results of all drawings are final and may not be appealed.

The official record shall contain at least:

- Date, time, and place of the drawing;
- Names of persons present;
- Description of the drawing procedure;
- Names of the selected winners meeting the prize draw requirements.

8. Prize Claim and Publication of Winners

A condition for receiving a prize is that participants:

- Meet the requirements set out in Article 3;
- Agree to these Terms and Conditions; and
- If selected as winners, provide the Organizer within **48 hours** via email to **marketing@gls-slovenia.com** with the information necessary for prize delivery:
 - First and last name;
 - Street address;
 - Postal code and city;
 - Telephone number.

The Organizer will deliver or transfer the prize no later than **four (4) weeks** after the relevant drawing and after receipt of all required winner information.

The winner must provide all requested, accurate, and complete information within the manner and timeframe specified by the Organizer.

Failure to provide the required information on time, or provision of incomplete or inaccurate information, shall be considered a waiver of the prize.

In such cases, the Organizer is not obliged to award the prize, and the prize shall remain unawarded unless the Organizer decides otherwise.

Prizes may not be exchanged for another prize, transferred to another person, or redeemed for cash, except where the prize is inherently monetary in nature.

The Organizer reserves the right not to award or to withdraw a prize if:

- The winner does not meet participation or prize claim requirements;
- The winner fails to provide all necessary, accurate, and complete information within the required timeframe;
- There is justified doubt regarding the winner's identity or the authenticity of the information provided;
- The winner participated contrary to these Terms and Conditions or through fraudulent, deceptive, or otherwise unauthorized conduct;
- The prize cannot be awarded for other reasons or would conflict with applicable law.

In all such cases, the Organizer shall be released from all obligations related to the award of the prize.

10. Limitation of Liability

The Organizer accepts no responsibility for:

- The operation or malfunction of social networking platforms (Instagram, Facebook, etc.);
- The operation or malfunction of the GLS application;
- Other technical issues affecting participation;
- Any consequences suffered by participants as a result of participating in the prize draw or using the prizes.

The Organizer reserves the right to amend these rules if required for technical, commercial, or public-interest reasons.

Participants will be informed of any changes and updates via announcements on the relevant website.

11. Protection of Personal Data

The Organizer will process the participant's personal data, namely:

- First name;
- Last name;
- Telephone number;
- Address;
- Email address

(hereinafter referred to as the "Data"),

which the participant will only be required to provide if selected as a winner, solely for the purpose of administering the prize draw.

During processing, participants have the right, in accordance with applicable legislation, to:

- Access their personal data;
- Rectify inaccurate data;
- Restrict processing;
- Request deletion of all or part of their data.

Participants also have the right to object to processing, the right to data portability, and the right to lodge a complaint.

Participants may at any time request that the Organizer permanently or temporarily cease using their personal data for direct marketing purposes.

Consent to receive electronic communications may be withdrawn at any time by written notice to the above postal or email address.

Personal data processed on the basis of consent for direct marketing purposes will be processed until consent is withdrawn. Withdrawal does not affect the lawfulness of processing carried out before such withdrawal.

Data processed on the basis of contractual obligations and legal requirements for the administration of the prize draw will be retained for **six (6) years** following completion of the prize draw or as otherwise required by law.

The recipient and user of the personal data is the Organizer's marketing department.

The Organizer will not disclose personal data to third parties.

12. Documentation

The Organizer shall retain documentation related to the prize draw as follows:

- Documentation relating to the organization and implementation of the prize draw, including these rules, shall be retained at the Organizer's premises for **three (3) years**;
- Documentation relating to winners (personal data notices, tax records, etc.) shall be retained in accordance with applicable tax and accounting regulations.

After the expiry of the applicable retention periods, the Organizer shall destroy the documentation in accordance with its internal policies.

14. Miscellaneous Provisions

The Organizer reserves the right to amend these Rules where required for legal, technical, or commercial reasons.

Participants will be informed of any amendments through a notice published on the **GLS Slovenia Facebook or Instagram page**, together with the prize draw rules.

Any disputes arising from the prize draw that cannot be resolved amicably shall fall under the jurisdiction of the competent court in **Ljubljana, Slovenia**.

These Rules shall enter into force on the date of their adoption.
