1. General Provisions

The following rules govern the organization and participation in the prize draw conducted by GLS General Logistics Systems Slovenia, Logistics Services Ltd.

The organizer of the prize draw is:

(hereinafter referred to as the "Organizer").

The prize draw is conducted within the territory of the Republic of Slovenia and runs from 1 June 2026 to 2 August 2026.

All participants entering the prize draw accept these Terms and Conditions, confirm that they are familiar with them, fully agree to them upon participation, and acknowledge that they meet all eligibility requirements. The Organizer considers that, by submitting an entry or participating in any other manner, each participant has expressed their intention to participate and has accepted all provisions of these Terms and Conditions.

2. Purpose of the Prize Draw

The purpose of the prize draw is to promote the GLS Send a Parcel service, encourage the use of the posljipaket.si portal, and increase the use of GLS Parcel Lockers.

Advertising and implementation of the prize draw are carried out in accordance with applicable legislation. The prize draw may also be communicated and promoted through other social media platforms and websites.

3. Participants

The prize draw is open to all natural persons who have permanent residence in the Republic of Slovenia.

The following persons are excluded from participation:

- Employees of GLS General Logistics Systems Slovenia;
- Their immediate family members (spouse, cohabiting partner, parents, children);
- Any other individuals directly involved in the organization and execution of the prize draw.

Each participant may participate only in their own name and, by entering the prize draw, confirms that all submitted personal data belongs solely to them and that they agree to these rules.

Participants must be at least 18 years of age.

If a participant or winner is under 18 years of age, they must be represented by a person over 18 years of age who is legally authorized and/or properly empowered to represent the minor.

4. Method of Participation

A participant may enter the prize draw by fulfilling all of the following conditions:

4.1.

Between 1 June 2026 and 2 August 2026, send a parcel via the posljipaket.si portal.

4.2.

At the final payment step, enter the discount code:

"NAGRADA"

Each participant may enter multiple times by sending multiple parcels.

Participants bear all costs associated with participation in the prize draw, including but not limited to:

- Internet access costs;
- Electricity costs;
- Postage and shipping costs.

If the winner is a child who does not possess a valid personal identification document, the name and surname of the parent or legal guardian must be provided.

5. Rules of Participation

5.1.

The winner expressly agrees that, in connection with the prize draw, the Organizer may publish their first and last name on the official GLS Slovenia Instagram and Facebook pages.

5.2.

Participants may not advertise any product or service, use inappropriate language, swear, or make statements that could be harmful or offensive to any person or institution.

Participants may not publish, submit, or otherwise distribute content containing:

- Advertising or promotion of third-party products or services;
- Inappropriate, offensive, vulgar, or indecent language;
- Hate speech;
- Threats;
- Any unlawful, misleading, discriminatory, harmful, or offensive content;
- Content that infringes upon the rights, reputation, or dignity of other persons, the Organizer, or third parties.

The Organizer reserves the right to exclude such participants from the prize draw without prior notice.

6. Prizes

Prizes will be awarded weekly, every Monday.

During the prize draw period, the following prizes will be awarded through weekly draws:

- Four (4) prizes worth EUR 1,000 each;
- Four (4) prizes worth EUR 350 each.

On the final day of the prize draw, one grand cash prize of EUR 3,000 will be drawn among all participants who meet the participation requirements.

If incomplete, inaccurate, or false information is provided, the Organizer reserves the right to reject participation or exclude the participant from the prize draw.

A participant forfeits the right to a prize if the Organizer determines that:

- The participant did not meet the participation requirements;
- The participant violated these rules;
- The participant refuses to fulfill obligations under these Terms and Conditions; or
- The participant fails to fulfill such obligations within the prescribed timeframe.

7. Draw Procedure, Prize Allocation and Winner Notification

Prize draws will be conducted every Monday until the end of the promotional period.

One participant who meets the requirements set out in Article 4 will be randomly selected from all eligible entries.

The draw will be recorded electronically, and minutes of the draw will be prepared.

The records will be kept at the Organizer's registered office in accordance with these rules.

The results of all draws are final and cannot be appealed.

The draw record shall contain at least:

- Date, time, and location of the draw;
- Persons present;
- Description of the draw procedure;
- Selected winners meeting the prize draw requirements.

8. Prize Collection and Publication of Winners

To qualify for a prize, participants must meet the requirements set out in Article 3 and agree to these Terms and Conditions.

If selected as winners, participants must submit the following information to marketing@gls-slovenia.com within 48 hours:

- First and last name;
- Street address;
- Postal code and place of residence;
- Telephone number.

The Organizer will deliver or transfer the prize no later than four (4) weeks after the relevant draw and after receiving all required information.

The winner must provide all requested, accurate, and complete information within the timeframe and manner prescribed by the Organizer.

If the winner fails to provide the requested information on time or provides incomplete or

inaccurate information, it shall be deemed that they have declined the prize. In such cases, the Organizer is not obliged to award the prize, and the prize shall remain unawarded unless the Organizer decides otherwise.

Prizes cannot be:

- Exchanged for another prize;
- Transferred to another person;
- Redeemed for cash,

unless the prize itself is monetary in nature.

The Organizer reserves the right not to award or to withdraw a prize if:

- The winner does not meet the participation or prize claim requirements;
- The winner fails to provide all required, accurate, and complete information within the prescribed period;
- There are justified doubts regarding the winner's identity or the authenticity of the submitted information;
- The winner participated in violation of these Terms and Conditions or through fraudulent, misleading, or otherwise prohibited conduct;
- Awarding the prize would not be possible or would conflict with applicable legislation.

In all such cases, the Organizer shall be released from any obligations relating to the prize award.

10. Limitation of Liability

The Organizer accepts no responsibility for:

- The malfunction or unavailability of social media platforms (Instagram, Facebook, etc.);
- The malfunction of the GLS application;
- Any other technical problems related to participation;
- Any consequences suffered by participants as a result of participating in the prize draw or using the prizes.

The Organizer reserves the right to amend these rules where required for technical, commercial, or public-interest reasons.

Participants will be informed of all changes and updates through announcements published on the Organizer's website.

Purpose and Legal Basis for Processing

- The legal basis for processing personal data is the participant's consent pursuant to Article 6(1)(a) of the EU General Data Protection Regulation (GDPR).

- Withdrawal of consent does not affect the lawfulness of processing carried out before its withdrawal.

Categories of Personal Data

The Organizer processes the following personal data:

- First and last name;
- Telephone number;
- Address;
- Email address.

Recipients of Personal Data

Personal data is processed by:

- The Controller's Marketing Department.

Personal data will not be disclosed to third parties except where necessary for administering the prize draw (e.g., delivery of prizes) or where required by law.

Data Retention Period

Data processed for the administration of the prize draw will be deleted after the prize draw concludes.

Data relating to winners and awarded prizes will be retained for 10 years after the conclusion of the prize draw, in accordance with applicable legal requirements.

Rights of the Data Subject

Participants have the following rights under applicable legislation:

- Right of access to personal data;
- Right to rectification of inaccurate data;
- Right to erasure ("right to be forgotten");
- Right to restriction of processing;
- Right to data portability;
- Right to object to processing;
- Right to withdraw consent (where applicable);
